The Summer Cultural Enrichment Program (SCEP) is a 6-week program for students ages 5-12 (SCEP Scholars), who engage in a daily schedule of educational and enrichment classes Monday-Thursday, and offsite field trips each Friday. Youth ages 13-21 may apply to participate in the work-based learning component of the program as Youth Leaders.

### **Frequently Asked Questions**

#### ***When is the program?***

The 6-week program will be held from 6/26/2017 to 8/4/2017.

#### ***When will applications be available?***

Monday, April 17<sup>th</sup>.

#### ***What days and times does the program take place?***

SCEP takes place from 10am-4pm Monday-Friday. Optional before-care is available from 9-10am. After 4pm, students may participate in the summer edition of EOYDC's After School Leadership Academy (ASLA). ASLA operates from 3:30-6pm in the summer.

#### ***Can I drop my child off before 9am?***

No; children may not be dropped off before 9am unless it is a field trip day that requires an earlier drop-off.

#### ***What ages do you accept?***

This program serves children between the ages of 5-12.

- Children must have turned 5 years old by September 1, 2016; proof of birth date, such as a birth certificate, must be provided to register a 5 year old in the program.
- Children must be no older than 12 years old as of the start of the program .
- Note: Youth ages 13-15 may register for EOYDC's free ASLA Teen Club Program; Youth grades 9-12 grades may register for EOYDC's Pathway to College & Careers Program; see front desk for more info

#### ***Is the program open to children who do not live in Oakland?***

Yes; however, there are a limited number of spaces for non-Oakland residents. Proof of residency (such as recent utility bills) will be required to apply for the program.

## Frequently Asked Questions (Continued)

### ***How much does the program cost?***

There is a non-refundable registration fee of \$100 (need-based fee waivers available). Program fees are based on household income:

- Low income (within 200% of Federal Poverty Limit) = Program fee waived
- More than 200% above Federal Poverty Limit, but less than Alameda County median = \$160
- Above Alameda County median income = \$400

Note: An income chart will be included on the application.

### ***Does my child have to attend all 6 weeks of the program?***

Yes. Because space is extremely limited, if a participant misses more than 3 days in a row or 5 days total, they will lose their space and their space will be open to someone on the waitlist.

### ***Does my child have to attend the full day?***

Yes; children are expected to arrive no later than 10:00am and be picked up no earlier than 4:00pm. If there is a doctor's appointment or another valid reason, we will accept late arrivals or early pick ups (except for field trip days). Otherwise, you may lose your slot if your child is not attending the full program each day.

### ***When are the mandatory parent orientation?***

You must attend one of the following mandatory sessions. If you do not, you will lose your slot.

- June 3 from 12:30-2pm **for new parents/guardians**
- June 3 from 2:15-3:15pm **for returning parents/guardians**
- June 6 from 5-6:30pm **for new parents/guardians**
- June 6 from 6:45-7:45pm **for returning parents/guardians**
- June 8 from 5-6:30pm **for new parents/guardians**
- June 8 from 6:45-7:45pm **for returning parents/guardians**

### ***What if I do not attend the mandatory parent orientation?***

If you or another legal parent/guardian do not attend a mandatory parent orientation, you will lose your slot. Even if you have attended in the past, there are changes each year that must be reviewed, so please note that there are NO EXCEPTIONS.
