PREVIOUS PARTICIPANTS: Our registration process has changed. Due to limited spaces available, and to ensure a pleasant and rewarding experience for everyone, we are reviewing the applications of past participants and will be granting space in the program for children who have demonstrated positive, cooperative behaviors and attitudes. **Therefore, please be advised that all applications will NOT be accepted.**

All applicants are required to attend a **MANDATORY** meeting before the start of the Summer Program. For your convenience, two meetings will be held: Tuesday, June 12, 2012 at 6:00 p.m. and Thursday, June 14, 2012 at 6:00 p.m. If these dates would change you will be notified. Please make arrangements to attend **one** of these meetings as **children who have not had a parent or guardian attend a meeting will not be accepted for enrollment.**

To ensure that programs and operations run smoothly we offer the following guidelines

Summer Program

- ❖ Please be sure your child has adequate food for breakfast and/or lunch as these meals are not provided by the EOYDC Summer Program. Be sure your child has change if given money for vending machines.
- ❖ Please drop your child off NO earlier than **9:00 a.m.** Summer Program activities end at **4:00pm**. Your child is welcome to participate in regular EOYDC program activities after summer program activities. However, children who are not actively involved in some form of EOYDC programming must exit the Center. (If your child will be walking home please indicate on the application form.)
- ❖ Children who are in need of continual disciplinary actions will be dropped from the Summer Program enrollment.
- ❖ By signing the application form you automatically give consent for your child to participate in field trips away from the EOYDC location.
